#### Item 1. Security and Issuer

This Amendment No. 2 to Schedule 13D (the "Second Amendment") amends and supplements the original Schedule 13D filed on June 11, 2015 (as amended by Amendment No. 1, the "Schedule 13D") and Amendment No. 1 to Schedule 13D filed on June 30, 2015 ("Amendment No. 1"). This Second Amendment is filed jointly on behalf of Carl H. Westcott, Commodore Partners, Ltd., G.K. Westcott LP, Carl Westcott, LLC, Jimmy Elizabeth Westcott, Chart H. Westcott, Court H. Westcott, and Carla Westcott (the "Reporting Persons") relating to their beneficial ownership of the common stock, par value \$0.50 per share (the "Common Stock") of Comstock Resources, Inc., a Nevada corporation (the "Issuer"), whose principal executive offices are located at 5300 Town and Country Blvd., Suite 500, Frisco, Texas 75034.

This Second Amendment is filed pursuant to Rules 13d-1 and 13d-5 under the Securities Exchange Act of 1934, as amended, to reflect a change aggregating more than one percent (1%) in the beneficial ownership of the outstanding Common Stock in which Carl H. Westcott may be deemed to have a beneficial interest. Unless otherwise indicated, all capitalized terms used herein but not defined shall have the same meanings as set forth in the Schedule 13D.

After accounting for all sales of Common Stock of the Reporting Persons since the filing of the Schedule 13D (the period of June 30, 2015 through July 2, 2015), a net 500,000 shares of Common Stock were purchased by Carl H. Westcott during such period on his own behalf and on behalf of certain other Reporting Persons for an aggregate price of approximately \$1,406,298.

Westcott as the managers of Carl Westcott, LLC, the sole general partner of Commodore Partners. GK Westcott holds 10,000 shares of Common Stock, over which Carl H. Westcott holds shared voting and dispositive power with Chart H. Westcott and Court H. Westcott as the managers of Carl Westcott, LLC, the sole general partner of GK Westcott.
